## RESOLUTION NO. 21-02

### A RESOLUTION OF THE VALLEY SPRINGS PUBLIC UTILITY DISTRICT BOARD OF DIRECTORS TO CHANGE THE BASE RATE CHARGE FOR WATER SERVICES EFFECTIVE October 1, 2021

**WHEREAS**, the Valley Springs Public Utility District (District) provides sanitary water collection and treatment services for District residents and property owners; and

**WHEREAS**, Current water charges will be insufficient to cover the anticipated cost of the necessary improvements to the Valley Springs Public Utility District water collection system and wastewater treatment facility; and

**WHEREAS**, a notice of the Public Hearing to consider proposed increases to the Water Rates was mailed 45 days prior to the scheduled Public Hearing as required by state law (Cal. Const. art. XIID, §6) and;

**WHEREAS**, on September 22, 2021, the Board conducted a Public Hearing, considered testimony, and at the conclusion of the protest hearing determined that the number of valid written protests received was less than 50% of the total number of water and wastewater customers or property owners subject to water rates in the City and approved the recommendations in the 2021 Water and Sewer Rate Study regarding adjustments to the Water Rates; and

**NOW THEREFORE, BE IT HEREBY RESOLVED**, by the Board of the Valley Springs Public Utility District that the Board hereby approves the Base Rate Charge, as set forth "Exhibit A" attached hereto and by this reference incorporated herein, to become effective October 1, 2021.
